Such purchaser at such tax sale will be required to pay ten percentum of his respective bid to the undersigned Village Treasurer immediately upon the completion of this sale and the remaining ninety per centum within ten days after the sale and upon such payment in full shall receive a written certificate of sale describing the real estate purchased and sum paid therefor.
