<b>The Village of Sea Cliff assumes no responsibility or liability for any boat stored on Village Boat racks. Boats, and accessory equipment in an assigned rack, must be removed by Owner no later than Dec. 31<sup>st</sup>. Boats and equipment not removed before Dec. 31<sup>st</sup>, may be removed and/or stored by Village at Owner's expense and WITHOUT FURTHER NOTICE. Costs for such removal and/or storage shall be paid by Owner prior to pick up, in an amount to be determined by the Board of Trustees, on an annual basis.</b>	\$125.00

**BOAT RACK RULES**

**BEACH MEMBERSHIP RULES:**

Only members of immediate family in applicant's residence are eligible. Children under age 9 must be with someone over 16. No glass or alcohol permitted on beach. No smoking on deck or beach. Air filled inflatables prohibited in beach area. Swim only within designated swimming area. No open fires permitted. Abide by Sec. 43-2 of the Village Code
