

**INCORPORATED VILLAGE OF SEA CLIFF**  
**2020 VILLAGE BEACH MEMBERSHIP AND BOAT RACK APPLICATION**

**Due to the COVID-19 Pandemic, Beach Membership is Limited to Sea Cliff Residents Only**

**BEACH MEMBERSHIP RULES**

Only members of immediate family in applicant's residence are eligible. Children under age 9 must supervised by someone over the age of 16. No glass or alcohol permitted on beach. No smoking on deck or beach. Air filled inflatables prohibited in beach area. Swim only within designated swimming area. No open fires or barbeques permitted. Abide by Sec. 43-2 of the Village Code. Abide by Beach Standards adopted by Board. Access and use of the village beach premises is subject to Village Code Sec. 43-2 and regulations adopted by the Board of Trustees.

In an effort to protect against the spread of COVID-19, and consistent with the New York State Department of Health interim guidance for beach activities during the COVID-19 Public Health Emergency issued on May 19, 2020, access and use of the beach area by members and guests shall be subject to regulations adopted by the Board of Trustees. All memberships are subject to compliance with such regulations, which regulations, as adopted, will be posted on the Village website and at beach. These regulations include, but are not limited to, limitations on occupancy to not more than 50% of capacity (presently determined to be not more than 100 people), residency restrictions, hours and dates of operation, closure of certain beach facilities, closure of shower facilities, bathroom restrictions, pavilion access limitations, social distancing mandates and gathering restrictions, wearing of masks or face coverings, and required spacing of blankets and chairs between groups.

Regulations may change during the beach season, and by submitting this application, I understand and agree to abide, and be bound, by such modified regulations.

Beach manager may cancel beach membership or rack use, or direct any person on the beach to leave the beach premises, for failure to comply with beach membership, standard safety rules, regulations, boat rack rules or standard safety rules.

**BOAT RACK RULES**

Boat Rack permit stickers must be purchased annually. Must have beach membership. Rack numbers assigned only by Beach Manager. Owners must put rack sticker number on boat transom. Unsuitable boats will be refused by Beach Manager. Maximum boat weight shall not exceed 150 pounds. All boats must be stored on racks none on or between rack ends. Boaters must swim in the designated swimming area. No boats may be moored offshore in the beach area. The Village of Sea Cliff assumes no responsibility or liability for any boat stored on Village Boat racks. Boats, and accessory equipment in an assigned rack, **must be removed by Owner no later than December 31**. Boats and equipment not removed before December 31, may be removed and/or stored by Village at Owner's expense and WITHOUT FURTHER NOTICE. Costs for such removal and/or storage shall be paid by Owner prior to pick up, in an amount to be determined by the Board of Trustees, on an annual basis.

**Assumption of Risk, Waiver of Liability and Indemnity Agreement**

In consideration of being permitted to utilize the Sea Cliff Beach premises, on behalf of myself and any of my family members, children or guests, understand and agree as follows.

- COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to be spread mainly from person-to-person contact. As a consequence, federal, state and local government agencies, and other public health agencies, have imposed various prohibitions, including the gathering of two or more people. Orders, guidance and protocols issued by these agencies provide for required and recommended social distancing, in an effort to prevent or slow the transmission of COVID-19.
- Consistent with guidelines of the New York State Department of Health, the Village has taken steps to implement recommended preventative measures to reduce the spread of COVID-19. Notwithstanding such measures, the Village cannot guarantee that you, your children or your guests will not become infected with COVID-19. While the measures are

consistent with guidelines put forth by the New York State Department of Health and other health agencies, attending the beach and using the facilities may increase your risk and the risk of your children or guests, to contracting COVID-19.

***In consideration of being permitted beach access as a member, on behalf of myself, guests and children, by signing this agreement, I agree to the following:***

Acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I, my children and/or my guests may be exposed to, or infected by, COVID-19, by using the Village Beach and that such exposure or infection may result in injury, illness, disability and/or death. I understand that the risk of such exposure or infection may result from the actions, omissions or negligence or myself or others.

VOLUNTARILY AGREE TO ASSUME ALL OF THE FOREGOING RISKS AND ACCEPT SOLE RESPONSIBILITY for any injury, illness, disability and/or death to my guests, children and myself, including, but not limited to, injury, illness, disability, death, damage, loss, claim, liability, or expense, of any kind, that my guests, children and/or I may experience or incur in connection with any COVID-19 related claims ("Claims").

RELEASE, WAIVE, DISCHARGE, COVENANT NOT TO SUE, AND HOLD HARMLESS, the Village, its officers, employees, volunteers, agents and representatives, of and from any Claims, of any kind arising out of or relating thereto. This release includes any Claims based on actions, omissions or negligence of the Village, its officers, employees, agents and representatives, whether a COVID-19 infection occurs before, during or after using the Sea Cliff Beach premises.
