BEACH MEMBERSHIP RULES:

Only members of immediate family in applicant's residence are eligible. Children under age 9 must be with someone over 16. No glass or alcohol permitted on beach. No smoking on deck or beach. Air filled inflatables prohibited in beach area. Swim only within designated swimming area. No open fires permitted. Abide by Sec. 43-2 of the Village Code

BOAT RACK RULES

Boat Rack permit stickers must be purchased annually. Must have beach membership. Rack numbers assigned only by Beach Manager. Owners must put rack sticker number on boat transom. Unsuitable boats will be refused by Beach Manager. Maximum boat weight shall not exceed 150 pounds. All boats must be stored on racks - none on or between rack ends. Boaters must swim in the designated swimming area. No boats may be moored offshore in the beach area. The Village of Sea Cliff assumes no responsibility or liability for any boat stored on Village Boat racks. Boats, and accessory equipment in an assigned rack, must be removed by Owner no later than Dec. 31st. Boats and equipment not removed before Dec. 31st, may be removed and/or stored by Village at Owner's expense and WITHOUT FURTHER NOTICE. Costs for such removal and/or storage shall be paid by Owner prior to pick up, in an amount to be determined by the Board of Trustees, on an annual basis.

BEACH MANAGER MAY CANCEL BEACH MEMBERSHIP OR RACK USE FOR FAILURE TO COMPLY WITH BEACH MEMBERSHIP OR BOAT RACK RULES OR STANDARD SAFETY RULES.

PLEASE MAKE CHECKS PAYABLE TO: INC. VILLAGE OF SEA CLIFF. UNCOLLECTED CHECKS WILL CANCEL MEMBERSHIP. RE-APPLICATION SHALL BE SUBJECT TO \$35.00 ADDITIONAL FEE.
